Dear Commissioners,

The Utah Solar Energy Association ("USEA") and the rooftop solar industry are writing to oppose the position Rocky Mountain Power ("RMP") proposed for rehearing in Docket No. 17-035-61 ("Docket") to calculate the capacity contribution for the export credit rate the Commission set in its October 30, 2020 order ("Order"). As you know, USEA is a party in this Docket, but it has not participated in the Rehearing because it appeared from early filings that any rate adjustment would be minor, and it did not have resources to continue. In addition, Ryan Evans, USEA's former president, moved out of state and the Association appointed Steve Mecham as its interim director. Consequently, we just became aware of RMP's position and must oppose it because it would further cripple the rooftop solar industry.

When the Commission granted rehearing, USEA believed parties would propose relatively minor calculation corrections that might alter the Commission's export credit rate tenths of a percent up or down. After reviewing testimony for the Rehearing, it appears RMP is proposing a new method for determining contribution capacity, not just a simple calculation change. What's more, RMP has already introduced this proposal in rebuttal testimony and at the hearing, and the Commission rejected it.

If we understand it correctly, RMP's proposal would slash the export rate an additional 41 - 43 percent from 5.6 - 5.9 cents per kilowatt-hour the Commission set in its Order to 3.2 - 3.5 cents, a pummeling the industry could not endure. Terminating the Net Metering program in 2017 and reducing the rate from one-for-one net metering to 9.2 cents was a blow to the industry. The Commission's Order last year cutting the rate 40 percent to one of the lowest in the nation at 5.6 - 5.9 cents and requiring an annual review sent the industry reeling. RMP's proposal in Rehearing could be the death knell of the rooftop solar industry and eliminate a competitive choice in the market.

Over the past year, approximately one-third of the solar companies in Utah have been forced to close their doors. Of those that remain, business has declined dramatically. It is becoming much more difficult for the industry to offer Utah customers affordable options for solar energy. USEA recognizes the Commission does not believe it has jurisdiction to consider impact on economic development, air quality, or the other public interest value of solar energy, but disregarding them has damaged the industry and the state.

USEA and the rooftop solar industry strongly urge the Commission to reject RMP's proposed new method for determining capacity contribution. That method artificially deflates the capacity value that the Commission has already recognized rooftop solar provides and will not fairly reflect the costs and benefits of rooftop solar. Additionally, the result will not be just, reasonable, or in the public interest.
