## NOTICE OF FILING

On December 11, 2017, Bringard Millworks, LC (Bringard) filed a formal complaint against Rocky Mountain Power (RMP), a public utility. Bringard alleges RMP illegally backbilled Bringard approximately \$22,577.07 on October 31, 2017, due to RMP's electric meter failing to correctly register. Bringard asserts RMP was aware the meter was improperly registering electrical usage beginning July 28, 2017, but did not render a back-bill until the October date. Bringard claims RMP is in violation of Electric Service Regulation No. 8R.3, ¶ 8(c), and Electrical Service Regulation No. 7R.4, ¶ 4(b).
