Pursuant to Utah Admin. Code r.746-1 and Utah Code Ann. §§ 54-4a-1 and 54-10a-301  
the Utah Division of Public Utilities (“Division”) and Utah Office of Consumer Services  
 (“Office”) file this Joint Motion for Order to Show Cause why Monticello Wind Farm, LLC’s  
Memorandums in Opposition to the Division and Office’s Motion for Summary Judgment

Should Not be Stricken. Monticello Wind Farm, LLC's ("MWF") filed two Memorandums on March 26, 2018 in response to motions filed by the Division and the Office. The Division and Office jointly request that the Commission order MWF to show cause why the filed Memorandums should not be stricken.

MWF's Memorandums both were filed with a header that is seemingly inconsistent with Utah Admin. R. 746-1-202 and Utah Rule of Civ. Procedure 10(a)(3) which both require that title to filings must include the name, address, email address, telephone number and bar number of the attorney or party filing the paper, and, if not filed by an attorney, the party for whom it is filed. The heading on the Memorandums filed by MWF on March 26, 2018 includes partial information for a Utah licensed attorney Aaron Pacini. The heading is only partially complete and does not identify Mr. Pacini as counsel for MWF nor does it include his bar number or other required information. Mr. Pacini has not appeared as counsel for MWF in this docket.

Counsel for the Office contacted Mr. Pacini by email to inquiring whether Mr. Pacini is representing MWF. Mr. Pacini's response is included in the email attached as Exhibit A. In relevant part Mr. Pacini states that "I did not file the document and have not seen it." And that "I have not made an appearance in this matter. I can also tell you that Corbett Gwilliam does not represent anyone in the cited matter." The Division and Office therefor request some clarification from MWF regarding whether the inclusion of Mr. Pacini's information on the header of the Memorandums was made in error and should be stricken from the documents, whether MWF is represented by counsel other than Mr. Pacini, or whether MWF is in fact represented by Mr. Pacini and an appearance of counsel is necessary.

For these reasons the Division and Office request an Order to Show Cause as to why the Memorandums should not be stricken in whole or in part.
