MONTICELLO WIND FARM, LLC OPPOSITION TO THE DIVISION OF PUBLIC UTILITIES AND OFFICE OF CONSUMER SERVICES' JOINT MOTION FOR ORDER TO SHOW CAUSE WHY MONTICELLO WIND FARM, LLC'S MEMORANDUMS SHOULD NOT BE STRICKEN

On March 30, 2018, the Utah Division of Public Utilities ("DPU") and Utah Office of Consumer Services ("OCS"), collectively ("Agencies") filed a joint Motion to Show Cause why Monticello Wind Farm, LLC's ("Monticello") Opposition to the Agencies' respective Motions for Summary Judgment should not be stricken for an inadvertent mistake—in a header. The Public Service Commission of Utah ("PSC") should deny the motion because it is both improper and extreme.

The PSC's current rules do not provide for an order to show cause. Therefore, the PSC finds the Utah Rules of Civil Procedure persuasive. *See* R746-1-105. The Rules state:

An application to the court for an order to show cause shall be made *only* for enforcement of an existing order or for sanctions for violating an existing order. An application for an order to show cause *must* be supported by an affidavit sufficient to show cause to believe a party has violated a court order.

Utah R. Civ. P. 7(q) (emphasis added).

The Agencies' motion for order to show cause *is not* for enforcement of an order, *is not* for sanctions of an order, and *is not* supported by an affidavit. Because the PSC does not have its own governing provision for an order to show cause, it should follow the Utah Rules of Civil Procedure and deny the Agencies' misconceived motion.

On March 26, 2018, Monticello Wind Farm, LLC and Ellis-Hall Consultants, LLC each filed a Memorandum opposing the Agencies' requests for summary judgment. An entity can represent itself through an officer or employee pursuant to Utah Admin. Rule 746-1-107(1)(c), and both Agencies have interacted directly with Kimberly Ceruti ("Ms. Ceruti") as the known and authorized representative of Monticello Wind Farm, LLC and Ellis-Hall Consultants, LLC. In preparing the March 26 Memoranda, a template from another document was used and incompletely fitted. This is no grounds for dismissal.

Mr. Moore of the OCS sent an email falsely stating that the Memoranda included a home address. They did not. To complain about an oversight in a header and then assert reckless misrepresentations is beyond hypocritical. Rather than contact Ms. Ceruti to inquire, the Agencies quickly aligned to file the Joint Motion.¹ It is unfathomable that the Agencies, if acting in good faith without bias, would file a motion to strike a substantive pleading without first making a simple phone call or sending a simple email to the contact person they have in this docket—Ms. Ceruti—all over a simple heading. In fact, Mr. Moore *refused* to take a call from Ms. Ceruti on April 2, 2018, at 12:37 pm and *refused* to respond to her email.

The Utah Rules of Civil Procedure require that the rules "shall be liberally construed and applied to achieve the just, speedy, and inexpensive determination of every action." URCP. 1. The Agencies violate both the spirit and the letter of this rule. The Agencies have long known how to contact Ms. Ceruti.² In fact, the OCS's own exhibit demonstrates that Mr. Moore *believed* that Ms. Ceruti "is a principal of either Monticello Wind or Ellis-Hall Consultants." At the very least, Mr. Moore should have *included* Ms. Ceruti in his email as the OCS has consistently done before. Emails (Ex. 1). The Agencies made *no* effort to contact her before quickly filing their Motion to seek "clarification" that their Motion purports is necessary.

The Agencies' recent obsession with technicalities demonstrates further collective institutional bias against Monticello. The DPU's motion for summary judgment cited to "Utah Admin. Code r.746-100." This series of rules has been repealed. Yet, Monticello did not move to dismiss the motion because it does not prejudice the parties. The error has been corrected through Errata. This administrative error, and its correction, does not prejudice any party and should not be the basis for striking the March 26 Memorandum. The March 26 Memorandum is substantive argument proving that there are significant disputed issues of material fact and should not be stricken from the record. The PSC should deny the motion.
