Rocky Mountain Power has spoken with counsel for Monticello Wind Farm, LLC this morning and the parties have agreed to an extension of the deadline for Rocky Mountain Power to respond to its Motion to Toll Interconnection Security Posting Pending Final Order on PURPA Contracting until Friday, July 13, 2018. Rocky Mountain Power believes that, based on ongoing discussions between PacifiCorp Transmission and Monticello Wind Farm, LLC, good cause exists for granting this extension, and it will not impede the orderly consideration of the motion.
