# ORDER GRANTING EXTENSION OF TIME TO RESPOND TO MOTION

ISSUED: July 10, 2018

On July 10, 2018, the Public Service Commission ("PSC") received a request from Rocky Mountain Power ("RMP") for an extension of time to respond to Monticello Wind Farm, LLC's ("MWF") Motion to Toll Interconnection Security Posting Pending Final Order on PURPA Contracting ("Motion"). RMP represents it has communicated with MWF and that MWF agrees to the extension. Good cause appearing, therefore, the PSC grants the Motion. RMP shall have until Friday, July 13, 2018 to file a response to the Motion.

On July 9, 2018, the PSC gave notice that it interpreted MWF's request in a footnote of its Motion to shorten the response period as a willingness to waive the opportunity to reply and asked MWF to notify the PSC in the event it wished to file a reply. In light of MWF's apparent agreement to an extension of the deadline to respond, the PSC is uncertain whether MWF desires an opportunity to file a reply. Therefore, the PSC will assume MWF wishes to file a reply and will refrain from issuing an order on the Motion until the time for a reply has elapsed (*i.e.*, 10 days from the date responses are filed) unless MWF provides notice to the PSC that it wishes to waive the opportunity to file a reply.
