ISSUED: January 30, 2018

On January 29, 2018, PacifiCorp, doing business as Rocky Mountain Power (“RMP”), filed an unopposed motion with the Public Service Commission (“PSC”) to amend the deadlines established in the PSC’s Notice of Comment Period (“Notice”) issued December 21, 2017 in this docket (“Motion”). RMP states it is authorized to represent that the Division of Public Utilities, the Office of Consumer Services, the Utah Industrial Energy Consumers, and the Utah Association of Energy Users support or do not oppose the Motion. Accordingly, RMP seeks to extend the January 31, 2018 deadline for their comments by one week, while acknowledging a commensurate one-week extension of the February 16, 2018 deadline for reply comments.

Therefore, good cause appearing and there being no objection, the Motion is granted.

AMENDED NOTICE OF COMMENT PERIOD

The amended deadline for RMP to file its comments regarding the ratemaking and deferred accounting treatment, including an estimate of the total expected benefit resulting from the 2018 Tax Act is **Wednesday, February 7, 2018**. Reply comments may be filed with the PSC on or before **Friday, February 23, 2018**.
