On March 7, 2018, the Public Service Commission (PSC) issued a Scheduling Order, Notice of Hearing, and Notice of Scheduling Conference (Scheduling Order) in this docket. The Scheduling Order requested parties provide input by April 10, 2018 on the necessity of a hearing in this docket. The PSC has considered the input filed on April 9 and 10, 2018, respectively, by US Magnesium, LLC and the Utah Industrial Energy Consumers. Additionally, PacifiCorp filed on April 11, 2018, a request to stay the deadline for input on whether a hearing is necessary, and the Division of Public Utilities (DPU) filed an opposition to that request on April 11, 2018.

In light of the request of PacifiCorp along with the DPU’s opposition to that request, the PSC gives notice that it will consider any further input with respect to the need for a hearing in this docket filed with the PSC by noon on Friday, April 13, 2018. The PSC intends to issue an order on the afternoon of Friday, April 13, 2018, indicating whether or not the hearing will be held as currently scheduled for Wednesday, April 18, 2018.

The PSC has not been asked to modify the reply comment deadline of Monday, April 16, 2018, and that deadline remains in force.
