ISSUED: September 21, 2018

On June 25, 2018, the Public Service Commission (“PSC”) issued a Scheduling Order, Notice of Technical Conference, and Notice of Hearing (“Scheduling Order”) in this docket. On September 20, 2018, Rocky Mountain Power (“RMP”) filed an Unopposed Motion to Extend and Amend Procedural Schedule (“Motion”). In its Motion, RMP indicates it is authorized to represent that no other commenting party in this docket opposes the Motion. Initial settlement discussions in this docket were held on September 19, 2018 among RMP, the Division of Public Utilities, the Office of Consumer Services, the Utah Association of Energy Users, the Utah Industrial Energy Consumers, US Magnesium LLC, and Nucor Steel-Utah (collectively, the “Parties”). Based on these discussions, the Parties agree that an extension and amendment to the procedural schedule is reasonable and will provide an opportunity to continue to hold settlement discussions to determine whether an agreement in this docket can be reached.

Good cause appearing, therefore, the Motion is granted. Accordingly, the remainder of the Scheduling Order is amended as follows, which the PSC adopts:
