Re: *Rocky Mountain Power's Proposed Tariff Revisions to Electric Service Schedule No. 37, Avoided Cost Purchases from Qualifying Facilities; Docket No. 17-035-T07*

Dear Ms. Saba:

The Public Service Commission of Utah (PSC) reviewed PacifiCorp's, doing business as Rocky Mountain Power (PacifiCorp), February 22, 2018 filing, proposing revisions to Sheet Nos. 37.3, 37.4, 37.5, 37.6, and 37.7 of Electric Service Schedule No. 37 (Schedule 37). The filing was made pursuant to the PSC's January 23, 2018 Order in Docket Nos. 17-035-T07 and 17-035-37. PacifiCorp represents the proposed updates to Schedule 37 pricing are consistent with the Proxy/Partial Displacement Differential Revenue Requirement (Proxy/PDDRR) methodology approved by the PSC for calculation of Electric Service Schedule No. 38 (Schedule 38) avoided cost prices, with certain exceptions. PacifiCorp requests the PSC approve the proposed revisions to Schedule 37, effective March 1, 2018.¹

The PSC also reviewed the Division of Public Utilities' (DPU) March 7, 2018 comments. The DPU evaluated PacifiCorp's proposed Schedule 37 rates and determined they are calculated in accordance with PSC-approved Proxy/PDDRR methodology used for Schedule 38, with some modifications. The DPU concludes PacifiCorp's February 22, 2018 filing complies with the

¹ Given PacifiCorp's request for expedited approval of its filing, on February 26, 2018, the PSC solicited input from the Division of Public Utilities (DPU) regarding whether the DPU could complete its review of PacifiCorp's filing before noon on February 28, 2018. If not, the PSC requested the DPU propose a schedule to accommodate its review. On February 27, 2018, the DPU filed an Action Request Response proposing to file its review with the PSC on March 7, 2018. On February 28, 2018 the PSC issued a Notice of Filing and Comment Period allowing for submittal of comments and reply comments on the filing on or before March 7, 2018 and March 14, 2018, respectively.

PSC's January 23, 2018 Order, and recommends the PSC acknowledge PacifiCorp's proposed tariff revisions.

Based on the PSC's review of PacifiCorp's filing, the DPU's comments and recommendations, and there being no objection to the filing, the PSC approves the proposed revisions to Schedule 37 Sheet Nos. 37.3, 37.4, 37.5, 37.6, and 37.7 of PacifiCorp's P.S.C.U. No. 50 Tariff, effective the date of this letter. The PSC directs PacifiCorp to file with the PSC revised Schedule 37 Tariff Sheets with an effective date consistent with the date of this letter.
