Dear Ms. Saba:

The Public Service Commission of Utah (PSC) reviewed the December 21, 2017 filing by PacifiCorp, doing business as Rocky Mountain Power (PacifiCorp), proposing changes to Sheet Nos. 2E.3, 31.1, 32.2, 73.4, 121.1, 121.2, and 135.1 of its P.S.C.U. No. 50 tariff (Tariff). PacifiCorp states the proposed changes to Electric Service Schedule Nos. 2E, 31, 32, 73, and 121 update them to exclude participation by customers taking service under Electric Service Schedule 136, Transition Program for Customer Generators (Schedule 136). PacifiCorp's proposed changes to Schedule 135 add further specificity to the definition of annualized billing period for irrigation customers taking service under Electric Service Schedule No. 10. According to PacifiCorp, the latter was agreed to by PacifiCorp on December 12, 2017 in response to the Office of Consumer Services' (OCS) November 8, 2017 comments in Docket No. 14-035-114. The proposed changes also include minor housekeeping and administrative changes. PacifiCorp requests these changes take effect January 22, 2018.

The PSC also reviewed the comments of the Division of Public Utilities (DPU) and the OCS, both filed on January 5, 2018. The DPU concludes the filing is necessary and the proposed changes to the Tariff sheets are accurate. The OCS concurs with PacifiCorp's assessment regarding Schedule 136 customers' participation in certain programs. In addition, the OCS states the proposed changes to Schedule 135 regarding annualized billing period language are necessary and address its comments filed in Docket No. 14-035-114. Both the DPU and the OCS recommend the PSC approve PacifiCorp's proposed changes as filed.
