In compliance with the Public Service Commission of Utah's (Commission) June 15, 2012, order on energy balancing account (EBA) filing requirements in Docket 09-035-15 (as modified by (1) stipulation and Commission order in Docket 12-035-67, and (2) the stipulation paragraph 9 in Docket 14-035-31), Rocky Mountain Power hereby submits its EBA Filing Requirement 6(b) for the period January 1, 2017 through December 31, 2017 (2018 Utah EBA). This filing requirement is being provided in anticipation of the annual 2018 Utah EBA application scheduled to be filed on March 15, 2018 in the format agreed upon in the settlement stipulation in Docket 14-035-31. Confidential information is provided subject to Commission Rule 746-1-602 and 746-1-603. As requested by the Commission, Rocky Mountain Power is also providing seven (7) printed copies of the filing via overnight delivery.

Note: At the time of completing this EBA Filing Requirement 6(b) for the 2018 Utah EBA, allocation factors for calendar year 2017 have not yet been finalized. The Company's annual EBA filing, due to be filed with the Commission on March 15, 2018, will include an updated version of EBA Filing Requirement 6(b) and will reflect final calendar year 2017 allocation factors.
