**ORDER**

On April 27, 2018, the Public Service Commission of Utah (PSC) issued an order in this docket (Order). Among other things, our Order approved PacifiCorp dba Rocky Mountain Power's proposed \$2.8 million rate increase on an interim basis pending the final results of the review of the Division of Public Utilities' (Division) audit and a hearing following that audit.

On May 24, 2018, the Office of Consumer Services (Office) and Utah Association of Energy Users (UAE) filed a Joint Petition for Review or Rehearing (Joint Petition), requesting the PSC to review and reverse its Order. On June 8, 2018, the Division filed a response to the Joint Petition, urging the PSC to deny the Joint Petition for the same reasons the PSC denied a similar petition in Docket No. 09-035-15.

The Joint Petition is denied. In denying the Joint Petition, we adopt and incorporate by reference our rationale set forth in our Order on Petitions for Agency Review or Rehearing, issued April 7, 2017, in Docket No. 09-035-15.<sup>1</sup>
