On May 25, 2018, PacifiCorp, dba Rocky Mountain Power (PacifiCorp), filed an Application for Approval of Solicitation Process (Application) for up to approximately 308,000 megawatt-hours per year, for up to 25 years, of new geothermal, solar photovoltaic, and/or wind resources that can achieve commercial operation before March 31, 2020. On June 5, 2018, the Public Service Commission (PSC) issued a Scheduling Order and Notice of Hearing (Scheduling Order), establishing a procedural schedule in this docket. On June 8, 2018, PacifiCorp filed a Motion to Stay Procedural Schedule in this docket and on the same day, the PSC issued an Order Granting Motion to Stay Procedural Schedule, staying the Scheduling Order until further written request by PacifiCorp.

On August 22, 2018, PacifiCorp filed a Motion to Withdraw Application without Prejudice, in accordance with Utah Code Ann. § 54-17-807 and Utah Administrative Code R746-1-203 and -301. PacifiCorp states its withdrawal is based on discussions with parties and the open rulemaking process required by Utah Code Ann. § 54-17-807 underway in Docket No. 18-R450-01. PacifiCorp also states no intervening party has yet filed comments on the Application. Therefore, no party will be disadvantaged if the PSC grants this Motion.

For good cause and there being no opposition to the Motion, it is granted. Accordingly, the Application is withdrawn without prejudice.

Judicial review of the PSC's final agency action may be obtained by filing a Petition for Review with the Utah Supreme Court within 30 days after final agency action. Any Petition for Review must comply with the requirements of Utah Code Ann. §§ 63G-4-401, 63G-4-403, and the Utah Rules of Appellate Procedure.
