On December 16, 2019, the Public Service Commission (PSC) issued a Scheduling Order and Notice of Hearing (“Scheduling Order”) in this docket. On February 21, 2020, the Division of Public Utilities (DPU) submitted a Motion to Amend Schedule (“Motion”). The DPU states parties to this docket have been involved in ongoing settlement discussions and requests the Scheduling Order be amended to allow for additional time to pursue a settlement prior to filing additional testimony. The DPU represents that Rocky Mountain Power, the Office of Consumer Services, Western Resource Advocates, Utah Clean Energy, and the Utah Association of Energy Users support the Motion and Sierra Club does not oppose it.

DISCOVERY
