ISSUED: March 12, 2020

On December 16, 2019, the Public Service Commission (PSC) issued a Scheduling Order and Notice of Hearing (“Scheduling Order”) in this docket. On February 21, 2020, the Division of Public Utilities (DPU) submitted a Motion to Amend Schedule (“Motion”). In response to the Motion, on February 24, 2020, the PSC issued an Amended Scheduling Order and Notice of Hearing (“February Scheduling Order”).

On March 12, 2020, DPU filed a Second Motion to Amend Schedule (“Second Motion”). DPU states parties to this docket have continued their ongoing settlement discussions and requests the February Scheduling Order be amended in anticipation of the filing of a Settlement Stipulation. Also, given the current concerns regarding COVID-19, the Second Motion requests the PSC authorize parties and witnesses, if so desired, to participate telephonically in the April 8, 2020 hearing.

DPU represents that Rocky Mountain Power, the Office of Consumer Services, Western Resource Advocates, Utah Clean Energy, the Utah Association of Energy Users, and the Sierra Club support the Second Motion.

Good cause appearing, the Second Motion is granted, including that any party or witness may participate in the April 8, 2020 hearing telephonically. The amended schedule in this docket shall be as follows:
