
Pursuant to Public Service Commission of Utah (Commission) rule R746-1-301, the Utah Division of Public Utilities (Division) files its "Unopposed Motion to Change Date of Scheduling Conference and Request for Expedited Consideration" (Motion). The Division respectfully requests that the Commission change the date of the scheduling conference in this matter from March 7, 2019 ,to March 5, 2019, and give this request expedited consideration.

On February 20, 2019, the Commission issued its notice setting the scheduling conference for March 7, 2019 at 1 p.m. However, all the parties to this docket have a previously scheduled meeting at that time involving parties from other states.

Accordingly, the Division requests that the date of the Scheduling Conference be changed to March 5, 2019 at a time convenient for the Commission, and also requests expedited consideration of this request due to the closeness in time of the requested new date. The Division is authorized to represent that Rocky Mountain Power, the Office of Consumer Services, and the Utah Association of Energy Users support or do not oppose this Motion. There are no other parties to this docket.

For these reasons and other good cause appearing, the Division requests that the Commission grant this Motion and schedule the technical conference in this docket for March 5, 2019, instead of March 7, 2019.
