1. I am citizen of the State of Colorado and I am over the age of 18 years old.
2. I have personal knowledge of the following unless otherwise indicated.
3. I am employed as General Manager for Empire Electric Association, Inc. (“EEA”).
4. When a new customer places an existing service that does not have an active service contract attached to it in his or her name, the customer is not required to sign a new service contract, but is required to sign a membership form, which requires payment for services received under the terms and conditions set out in the applicable rate schedule.
5. Because the service fits the availability requirements of the General Service – Single-Phase rate and because it does not fit any other more specific service category, the rate

schedule applicable to the well service placed in Mr. Musumeci's name is the General Service–Single-Phase rate. This rate is denoted as “C1” on billing invoices. A billing invoice showing the applicable rate is attached as **Exhibit 1**.

6. That rate includes a \$32.00 grid access charge.

7. Pursuant to Utah Code Ann. §78B-18a-106, I declare under criminal penalty under the law of Utah that the foregoing is true and correct.

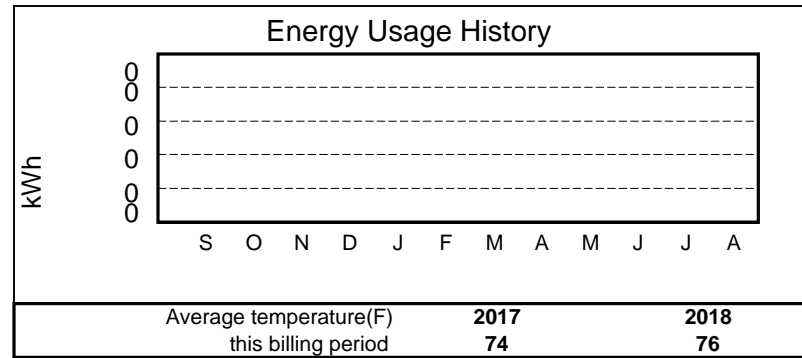

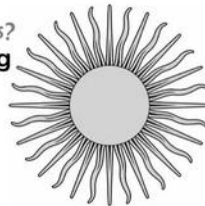


JUST FOR YOU
