ISSUED: August 7, 2019

On July 18, 2019, the Public Service Commission (PSC) issued its Order Dismissing Complaint (“Order”), dismissing the formal complaint that Joseph Anthony Musumeci (“Complainant”) filed in this docket against Empire Electric Association, Inc. (“Empire”). On July 18, 2019, Complainant submitted an email (“Request for Rehearing”) stating he “want[ed] to file a rehearing for this case” and declaring “[t]he ruling was unfair and unjust to me as [a] consumer of electricity.” The email offered no additional argument or assertions in support of the Request for Rehearing. On August 1, 2019, Empire submitted a Response to Complainant’s Request for Rehearing (“Response”), arguing “Complainant has not provided any substantive basis for reconsideration” and asking the PSC to deny the request.

Having reviewed the Request for Rehearing and the Response, the PSC concludes Complainant has provided no basis upon which the PSC may or should reconsider or rehear this matter. The Request for Rehearing is denied.
