This filing requirement is being provided in anticipation of the annual 2019 Utah EBA application scheduled to be filed on March 15, 2019 in the format agreed upon in the settlement stipulation in Docket No. 14-035-31. Note: At the time of completing this EBA Filing Requirement 6(b) for the 2019 Utah EBA, jurisdictional allocation factors for calendar year 2018 have not yet been finalized. The Company's annual EBA filing, due to be filed with the Commission on March 15, 2019, will include an updated version of EBA Filing Requirement 6(b) and will reflect final calendar year 2018 jurisdictional allocation factors.
