TARIFF STATUS

On March 15, 2019, PacifiCorp filed proposed revisions to Electric Service Schedule No.

94, Energy Balancing Account (EBA) together with its application to recover \$23.9 million in

deferred EBA costs through the Energy Balancing Account Mechanism (Application). Because

PacifiCorp's Application proposes a rate increase, it will not become effective automatically 30

days after filing. See Utah Code Ann. § 54-7-12(5)(a). Thus, suspending the tariff is unnecessary.
