Among other things, our Order approved PacifiCorp's proposed \$23.9 million rate increase on an interim basis pending the final results of the review of the Division of Public Utilities' audit and a hearing following that audit.

On May 13, 2019, the Office of Consumer Services and the Utah Association of Energy Users filed a Joint Petition for Review or Rehearing (Joint Petition) requesting the PSC to review and reverse its Order. No party filed a response to the Joint Petition.

The Joint Petition is denied. In denying the Joint Petition, we adopt and incorporate by reference our rationale set forth in our Order on Petitions for Agency Review or Rehearing, issued April 7, 2017, in Docket No. 09-035-15.¹
