)	Motion Requesting Change in the Date for the Status and Scheduling Conference and for Expedited Treatment

Pursuant to Utah Code § 54-10a-301 and Utah Admin. Code r. 746-1 the Office of Consumers Services (“Office”) submits this Motion Requesting a Change to the Date for the Status and Scheduling Conference in Dockets Nos. 17-035-01, 18-035-01 and 19-035-01 and for Expedited Treatment. On June 28, 2019, the Utah Public Service Commission (“Commission”) issued the Notice of Status and Scheduling Conference (“June 28th Notice”), to be held on July 10, 2019, in response to the Utah Supreme Court opinion of *Utah Office of Consumer Services, et al. v. Public Service Commission, et al.*, 2019 UT 26. The Commission issued the June 28th

Notice for the purpose of discussing “a process for determining and implementing the Opinion’s ramifications” June 28, 2019 Notice at 1.

The Office and the Utah Association of Energy Users (“UAE”) were Joint Petitioners in the appeal. The UAE has informed the Office that counsel for UAE will be out of state during the week of July 10th and will therefore not be able to attend the conference as scheduled but is available on July 16th, 2019 at 1:30. Accordingly, the Office moves for the Status and Scheduling Conference to be rescheduled for July 16th, 2019 at 1:30 or a time convenient for the Commission. Counsel for the Office contacted counsel for Respondents PacifiCorp dba Rocky Mountain Power and the Utah Division of Public Utilities and can represent that these Respondents do not object to rescheduling the conference and are available at the above requested date and time. Because this Motion is filed just two days before the scheduled Status and Scheduling Conference, the Office requests that this Motion be dealt with on an expedited basis.
