PETITION TO INTERVENE OF STADION, LLC

Pursuant to Utah Code Ann. § 63G-4-207 and Utah Admin. Code R746-1-108, Petitioner Stadion, LLC (“Stadion”) respectfully petitions the Public Service Commission (“Commission”) for leave to intervene in this docket. In support of this petition, Stadion states the following:

1. Stadion is a limited liability company that is wholly owned by Facebook, Inc. Stadion is developing a data center in Eagle Mountain, Utah.
2. PacifiCorp, dba Rocky Mountain Power, has filed its Integrated Resource Plan in this docket. As a retail electric customer of Rocky Mountain Power, Stadion’s legal rights and interests may be substantially affected by this proceeding.
3. Stadion has not yet determined the specific positions it will take or the relief it will seek. Stadion seeks to intervene for purposes of protecting its interest as they arise.
