ISSUED: February 28, 2019

On February 25, 2019, Sundial Lodge Homeowners Association (Sundial) filed a formal complaint with the Public Service Commission of Utah (“PSC”) regarding a planned power outage by Rocky Mountain Power (“RMP”), which was scheduled to occur on February 28, 2019. On February 25, 2019, the PSC issued an action request to the Utah Division of Public Utilities (“DPU”) instructing it to investigate the dispute and recommend an appropriate course of action.<sup>1</sup> On the same day, the PSC issued a Notice of Filing and Comment Period with RMP’s response to Sundial’s complaint and Sundial’s reply comments due no later than March 27, 2019 and April 11, 2019, respectively.

On February 27, 2019, Sundial filed a Notice of Withdrawal of its complaint, notifying the PSC that it and other affected parties had reached an agreement with RMP to reschedule the planned outage on March 5, 2019.

ORDER

Given the foregoing, the PSC vacates its February 25, 2019 Notice of Filing and Comment Period and notifies parties that it will take no further action in this docket.
