Application to Revise Rates in Tariff Schedule 98, Renewable Energy Credits Balancing Account

The Scheduling Order, Notice of Hearings, and Tariff Status issued by the Public Service Commission of Utah on March 29, 2019 in the above referenced proceeding (“Scheduling Order”) established a hearing on August 27, 2019 to address any issues raised by parties in their review and audit of the 2019 REC Balancing Account. The Division of Public Utilities (“Division”) filed its comments and audit report on July 11, 2019 concluding:

The Division’s audit found no discrepancies in RMP’s records of the 2018 REC transactions. Based on a review of the associated 2018 REC tariff, Schedule 98, and related 2018 filings with the Utah Public Service Commission, Rocky Mountain Power appears to be in compliance with regulatory and reporting requirements and the interim rates appear to be just and reasonable and in the public interest and should be made final.

The Scheduling Order specified that parties could comment as to whether the August 27, 2019 hearing was necessary. The Company contacted the Division and the Office of Consumer Services (“Office”) on the matter and is authorized to represent that the Company, the Division and the Office support cancelling the hearing scheduled for August 27, 2019. Due to this support and the absence of issues raised by any other interested party in August 1, 2019 comments provided under the Scheduling Order, the Company respectfully requests the Commission cancel the hearing and issue an order establishing final rates previously approved in the May 24, 2019 order.
