Pursuant to the Order issued by the Public Service Commission of Utah on February 16, 2017 in Docket No. 17-035-04, Rocky Mountain Power (the "Company") must file its Annual Energy Efficiency and Peak Load Reduction Report ("Annual Report") between May 1<sup>st</sup> and June 1<sup>st</sup> annually.

The Company respectfully requests a one-time extension for the 2018 Annual Report to be due no later than June 18, 2019. The Company's intent is to still file the 2018 Annual Report by June 1<sup>st</sup> if possible, but due to unexpected employee turnover the Company reasonably anticipates the possibility of needing additional time to complete the 2018 Annual Report. The Company believes the extended timeframe will be adequate to reconcile data and finalize the report, if needed.
