Dear Commissioners:

Pursuant to Utah Code Ann. § 54-17-502(6)(b), Rocky Mountain Power (the “Company”) hereby advises the Public Service Commission of Utah that it reasonably anticipates it will acquire or construct the following renewable resources during the remainder of 2019 or in 2020:

1. Pryor Mountain Project, capacity of 240 megawatts (“MW”), located in Carbon County, Montana.
2. Hill Air Force Base Blue Sky Project, capacity of 0.3 MW, located in Hill Air Force Base, Utah.
3. Moab Blue Sky Project, capacity of 0.3 MW, located in Moab, Utah.
4. Foote Creek I, capacity of 40.8 MW, located in Rock River, Wyoming.

In addition, the Company may pursue other renewable resource projects in 2020 if the opportunity arises. Please feel free to direct any inquiries regarding this matter to Jana Saba, at (801)-220-2823, or, myself at the number indicated above.
