On December 3, 2019, Rocky Mountain Power (RMP) filed its application in this docket, including a settlement agreement joined by multiple parties from all six states within RMP's service territory. Three parties have subsequently filed written testimony. All three are signatories to the settlement agreement and all three recommend approval of the application.

We recognize the significant amount of work all parties have put into the settlement agreement, and typical practice is to provide a hearing to present the filed testimony under oath. In light of current efforts to limit in-person gatherings, though, we are requesting comments on whether the hearing scheduled for Tuesday, March 24, 2020, is necessary. In the alternative, comments also may address whether a fully telephonic hearing would be appropriate.

Any interested person may submit comments on this issue by **Thursday, March 19, 2020**.
