On May 9, 2019, PacifiCorp filed Advice No. 19-09 proposing revisions to Electric Service Schedule No. 73, Subscriber Solar Program Rider Optional ("Schedule 73"), Sheet Nos. 73.1, 73.2, 73.3, and 73.4. PacifiCorp's proposed modifications to Schedule 73 include adding an option for customers to subscribe to 100 percent of their usage and to remove certain tariff rate schedules from being eligible to participate due to lack of customer interest. PacifiCorp proposed an effective date of June 30, 2019 for these changes.

On May 10, 2019, the Public Service Commission ("PSC") issued a notice of filing and comment period with comments and reply comments due by May 23 and May 30, 2019, respectively.

Subsequently, the Office of Consumer Services ("OCS") and the Division of Public Utilities ("DPU") filed comments recommending the PSC not approve PacifiCorp's proposed changes to Schedule 73. On May 30, 2019, PacifiCorp filed reply comments stating it would like to address parties' concerns but was unable to do so prior to filing its reply comments. Therefore, PacifiCorp supports a suspension order. PacifiCorp states it will work with parties and, subsequent to informal workshops, will file supplemental information and request a scheduling conference to allow for another round of comments in this docket.
