ISSUED: July 19, 2019

On July 16, 2019, the Public Service Commission (PSC) held a status and scheduling conference to discuss the implementation of the Utah Supreme Court's decision in *Utah Office of Consumer Services, et al. v. Public Service Commission of Utah, et al.*, 2019 UT 26 (the "Opinion") with respect to Docket Nos. 17-035-01, 18-035-01, and 19-035-01. During the conference, the parties agreed Rocky Mountain Power (RMP) would file, on or before July 19, a request to set the Energy Balancing Account collection rates ("EBA Collection Rates") to zero as of August 1, 2019. The parties also agreed to a schedule allowing interested parties until August 16, 2019 to file comments relating to any issue arising out of the Opinion's implementation and to file reply comments on or before August 30, 2019 (collectively, the "Comment Period"). The PSC approved and adopted the Comment Period in the Scheduling Order it issued on July 17, 2019.

On July 18, 2019, RMP filed a request to set the EBA Collection Rates to zero ("Request"), representing it is "authorized to represent that the Parties support [RMP's] tariff filing proposing to set the EBA rates to zero, effective August 1, 2019, and further support expedited treatment of this matter to meet the proposed effective date."

The filing or election not to file such comments shall not affect, in any manner, the ability or opportunity of a party to raise any issue during the previously noticed Comment Period. The PSC issues this notice only to ensure the parties have an opportunity to comment, in the event they wish to do so, on the Request before its requested effective date.
