SECOND NOTICE OF FILING AND COMMENT PERIOD AND ORDER SUSPENDING TARIFF

ISSUED: November 26, 2019

On November 18, 2019, Rocky Mountain Power (RMP) filed proposed revisions to Electric Service Schedule No. 120, Plug-in Electric Vehicle Incentive Pilot Program ("Tariff Revisions"), with an effective date of December 18, 2019. On November 20, 2019, the Public Service Commission (PSC) issued a Notice of Filing and Comment Period, establishing comment and reply deadlines of December 3 and December 10, 2019, respectively ("Procedural Schedule"). On November 25, 2019, ChargePoint, Inc. ("ChargePoint") filed a combined motion to intervene and a motion for extension of procedural schedule ("Combined Motion"). The Combined Motion requests, in part, the PSC grant a two-week extension to the comment and reply comment deadlines in the Procedural Schedule as well as to RMP's proposed effective date for the Tariff Revisions. ChargePoint asserts "[t]he [PSC] would benefit from this modest extension as it would provide interested parties with the necessary time to fully address the complexity of the issues involved in this proceeding." 1

Accordingly, for good cause appearing, and because we did not hold a scheduling conference in this docket at which ChargePoint could have requested the extended schedule, an opportunity we typically offer to participants who have not yet been granted intervention, the PSC gives notice any interested party may submit comments on the Tariff Revisions on or before
