Pursuant to Utah Code Ann. § 52-4-207, on this January 14, 2021, the chair of the Public Service Commission makes this written determination that, due to the COVID-19 pandemic and the continued risks of transmission in Utah, the hearing scheduled for **Thursday, January 21, 2021, beginning at 9:00 a.m.** will be conducted as a virtual meeting without an anchor location. An anchor location would provide a substantial risk to the health and safety of those who may be present at the anchor location.
