During the hearing the Public Service Commission (PSC) held on January 21, 2021, parties discussed the need for additional discovery, testimony, and a hearing in this docket regarding the Lake Side 2, Unit 3 outage that occurred on August 18, 2019. Accordingly, the PSC approves and adopts the following schedule:

NOTICE OF VIRTUAL HEARING

Pursuant to Utah Code Ann. § 52-4-207, on this January 26, 2021, the chair of the PSC makes this written determination that, due to the COVID-19 pandemic and the continued risks of transmission in Utah, the hearing scheduled for **Friday, February 12, 2021, beginning at 9:00 a.m.** will be conducted as a virtual meeting without an anchor location.
