On March 20, 2020, the Utility Facility Review Board (“Board”) issued a Notice of Telephonic Hearing on Petition to Intervene, providing notice the Board would conduct a telephonic hearing to consider the Petition to Intervene on Tuesday, March 31, 2020 at 10:00 a.m. (“March Hearing”). The March Hearing will be conducted as an electronic meeting pursuant to Utah Executive Order No. 2020-5, Suspending the Enforcement of Provisions of Utah Code Sections 52-4-202 and 52-4-207, and Related State Agency Orders, Rules, and Regulations, Due to Infectious Disease COVID-19 Novel Coronavirus (available at <https://rules.utah.gov/wp-content/uploads/Utah-Executive-Order-No.-2020-5.pdf>).

The Board gives notice it will consider, in addition to the Petition to Intervene, two other matters at the March Hearing:

- (1) whether the hearing on the merits in this docket, set to commence on Monday, April 20, 2020, shall be a telephonic hearing; and
- (2) whether to adopt an administrative rule addressing electronic meetings.

If the Board approves the administrative rule, it will be published in the Utah State Bulletin for a public comment period. The text of the proposed administrative rule follows:

**R746-14-101. Title and Definitions.**

- (1) This rule R746-14 is known as the “Utility Facility Review Board Rule.”
- (2) As used in this rule R746-14, “Board” means the Utility Facility Review Board created in Utah Code Section 54-14-301.

**R746-14-102. Authority.**

This rule is adopted pursuant to Utah Code Section 54-14-104.

**R746-14-103. Electronic Meetings.**

- (1) An electronic meeting may be scheduled:
  - (a) by the Board on its own initiative; or
  - (b) at the request of an interested person who is unable to attend in person.
- (2) A person who requests an electronic meeting pursuant to R746-14-103(1)(b) shall submit the request to the Board at least three business days prior to the scheduled meeting date and time.
- (3) A quorum of the Board is not required to be present at a single anchor location for an electronic meeting.
- (4) Any number of separate connections for participants is allowed for an electronic meeting, unless the Board limits the number of separate connections based on available equipment capability or other relevant and reasonable considerations.
- (5) An electronic meeting will not be separately noticed solely to inform the public that one or more participants, including Board members, will participate telephonically.
