ISSUED: April 9, 2020

On March 13, 2020, Valley-Wide Opposition to Large Transmission Lines (VOLT) filed a Petition to Intervene (“Petition”) in this docket. Rocky Mountain Power (RMP) filed an opposition to the Petition on March 23, 2020, and VOLT submitted a reply in support of its Petition on March 31, 2020.

On March 31, 2020, the PSC conducted a telephonic hearing to consider the Petition. After hearing the parties’ arguments, the Board deliberated and delivered its ruling on the record, granting the Petition pursuant to Utah Code Ann. § 63G-4-207.¹ In so doing, the Board adopted conditions to govern VOLT’s participation in the docket as follows:²

- (1) VOLT’s participation is limited to the issues Midway City raised in its Counter-Petition for Review, filed February 21, 2020;
- (2) Within the scope of its allowed participation as established in the preceding paragraph, VOLT may call two witnesses and will be allowed an opportunity to cross-examine other parties’ witnesses; and

(3) The Board reserved the right to further refine the scope of VOLT's participation as the proceedings move forward.³

Accordingly, this written order memorializes the Board's decision to grant VOLT's Petition as conditioned herein.
