On March 19, 2020, Western Resource Advocates petitioned for leave to intervene in this docket.

Intervention is conditioned upon the intervenor's representatives participating in this matter adhering to the Utah Standards of Professionalism and Civility adopted by the Utah Supreme Court October 16, 2003.
