On June 9, 2020, the Public Service Commission (PSC) issued a Scheduling Order, Notice of Technical Conferences, Notice of Hearings, and Notice of Public Witness Hearing (“Scheduling Order”) in this docket. The Scheduling Order indicated dates and times for upcoming technical conferences and stated that logistical information for participation in the technical conferences would be forthcoming.

Pursuant to Utah Code Ann. § 52-4-207, on this July 8, 2020, the chair of the PSC issues this notice and written determination that, due to the COVID-19 pandemic and the continued risks of transmission in Utah, the technical conferences scheduled for **Friday, July 10, 2020, beginning at 1:00 p.m.** and **Monday, July 27, 2020, beginning at 1:00 p.m.** will be conducted as electronic meetings without an anchor location. An anchor location would provide a substantial risk to the health and safety of those who may be present at the anchor location.
