**PETITION TO INTERVENE OF THE  
UNIVERSITY OF UTAH**

Pursuant to Utah Code Ann. § 63G-4-207 and Rule R746-1-108, Petitioner University of Utah (“Petitioner”) hereby petitions for leave to intervene in this docket.

In support of this petition, Petitioner states as follows:

1. Petitioner is a public flagship research university and a large electric consumer that is a customer of Rocky Mountain Power and whose rates are affected by Rocky Mountain Power’s rate structure.
2. Petitioner is also the only Utah ratepayer taking power pursuant to Rocky Mountain Power’s Electric Rate Schedule 32.
3. The legal rights and interests of Petitioner may be substantially affected by this proceeding.

4. Petitioner has not fully determined the specific positions it will take or the relief it will seek. Petitioner seeks to intervene for the purposes of protecting its interests as they may appear, particularly on issues of relevance to large electric customers and consumers taking power pursuant to Schedule 32.

5. The interests of justice and the orderly and prompt conduct of this proceeding will not be materially impaired by allowing Petitioner to intervene.
