REQUEST FOR CLARIFICATION RE AMENDED SCHEDULING ORDER AND NOTICE OF ELECTRONIC HEARING

Rocky Mountain Power (“RMP”), through counsel, requests clarification from the PSC of its November 12, 2020 Amended Scheduling Order and Notice of Electronic Hearing (“Order”).

I. CLOSING ARGUMENTS

During the Phase 2 hearings, RMP asked the PSC to consider closing briefs or argument at the conclusion of all phases of the hearing. The PSC asked for input from all interested parties, and on November 12, 2020 issued the Order.

The Order states, “[a]ll parties must have their witnesses in attendance and prepared to provide their closing statements.” Order at p. 2. RMP asks the PSC to clarify (1) if intends to hear closing arguments from attorneys only, rather than witnesses, and (2) whether attendance by

all witnesses of all parties, including retained experts or witnesses who were not crossed, is mandatory.

The request for oral argument made by RMP was made seeking closing arguments from attorneys on behalf of their clients. Closing statements made by witnesses may be problematic, as it would act as live sur-surrebuttal testimony, which would not be subject to cross examination. Further, RMP will attempt to have its retained witnesses attend if required by the PSC, but hopes to clarify whether such attendance is actually sought by the PSC.
