**Notice of 2020 All Source Request for Proposals** 

Dear Commissioners:

PacifiCorp, d.b.a. Rocky Mountain Power (the "Company"), hereby notifies the Public Service Commission of Utah (the "Commission") of its intent to seek approval of a solicitation process under Part 2 of the Energy Resource Procurement Act, Utah Code Ann. Title 54, Chapter 17. The Company anticipates filing its application for approval of its all source request for proposals ("2020 All Source RFP") on March 23, 2020. Consistent with Commission's Administrative Procedures Act Rule R746-420-1(3)(a), the Company provides this 60 day notice to allow the Commission to promptly hire an independent evaluator to monitor the 2020 All Source RFP as required by Utah Code Ann. §54-17-203.

The 2020 All Source RFP will solicit bids for up to 6,000 MW of renewable and non-renewable resources plus approximately 600 MW of storage battery, all capable of delivering energy and capacity to PacifiCorp's system for service on or before December 31, 2023. The 2020 All Source RFP will permit qualified bidders to submit bids under power purchase agreements and build transfer agreements. The Company does not anticipate submitting any self-build (i.e. benchmark) bids or allowing any bids from PacifiCorp's affiliates.
