On May 22, 2020, Utah Clean Energy petitioned for leave to intervene in this docket.

Because no party has objected to the petition and good cause otherwise appears to exist, the Public Service Commission (PSC) will grant intervention. Intervention is conditioned upon the intervenor's representatives participating in this matter adhering to the Utah Standards of Professionalism and Civility adopted by the Utah Supreme Court October 16, 2003. Leave to intervene is granted to Utah Clean Energy. Intervention is granted as described above.
