# ORDER GRANTING REQUEST FOR FINAL SHORTLIST REPORT

On October 4, 2021, Rocky Mountain Power (RMP) filed a Request for Final Shortlist Report ("Request"), requesting a copy of the highly confidential version of the Final Shortlist Report on PacifiCorp's 2020 All Source Request for Proposals ("Final Report") referenced in the Public Service Commission of Utah's (PSC) Notice, dated September 3, 2021. An order of the Public Utility Commission of Oregon ("Oregon PUC") directing PacifiCorp to provide the Oregon PUC with a copy of the Final Report is attached to the Request, as is a protective order to "prevent PacifiCorp's counter-parties or potential counter-parties from accessing bid information." RMP also attached a Non-Disclosure Agreement consistent with Utah Admin. Code R746-1-602(1)(b).

The PSC issued a Notice of Request and Expedited Period to Respond on October 4, 2021. No party has filed any objection or response to the Request.

There being no opposition and good cause otherwise appearing, the Request is granted.
