On February 2, 2021, in accordance with the Public Service Commission's (PSC) Order Approving Accounting Order ("Order") issued September 15, 2020 in this docket, Rocky Mountain Power (RMP) filed its quarterly compliance filing for the period ending December 31, 2020. The PSC issued an action request to the Division of Public Utilities (DPU) requesting the DPU review RMP's filing for compliance. On February 24, 2021, the DPU filed its response.

The Order authorized RMP to "establish a regulatory asset to record costs associated with its COVID [Public Health Emergency (PHE)] response, effective until December 31, 2020."¹ On February 25, 2021, the PSC issued a supplemental action request to the DPU. The supplemental action request asked the DPU to "provide an evaluation and recommendation pertaining to the December 31, 2020 expiration [("Expiration Date")] of the COVID PHE deferral period and regulatory treatment of the deferral balance."² On March 4, 2021, the DPU filed its response ("DPU's Response") to the supplemental action request.

Any interested party may submit comments on the DPU's Response or on the Expiration Date on or before **Friday**, **March 19**, **2021**.
