**RE: Docket No. 20-035-29 – Annual Cost of Service Study - 2019**

The Public Service Commission of Utah's order dated November 23, 1999, in Docket No. 98-2035-04, item 17 (f) requires PacifiCorp, d.b.a Rocky Mountain Power, (the "Company") to file an annual cost of service study based on the prior year historical data ("1999 Order"). Per the Commission's letter dated May 29, 2014 in Docket No. 14-999-01, the annual cost of service study is due within 45 days of filing the year-end results of operations, which are typically filed around April 30 of each year.

The annual cost of service report for the historical period of the 12 months ended December 31, 2019 was provided on May 8, 2020 as part of the Company's general rate case filing in Docket No. 20-035-04. Specifically, the cost of service study can be found as Attachment R746-700-22-C.1. This cost of service study is based on the historical Jurisdictional Allocation Model ("JAM") that was provided as R746-700-20-A.1, which is the same JAM that was filed with the December 2019 Results of Operations in Docket No. 20-035-15 on April 30, 2020. The Company believes that this meets the requirement of the 1999 Order.


