RE: **Docket No. 20-035-37 – In the Matter of the Application of Rocky Mountain Power for Approval to Enter into Resource Contracts in Excess of Fifteen Years Pursuant to Commission Approved Agreements under Electric Service Schedule Number 34**


On October 20, 2020, PacifiCorp, d. b. a. Rocky Mountain Power (“the Company”) filed a Settlement Stipulation in the above referenced matter, which was signed by the Company, the Division of Public Utilities and the Office of Consumer Services (“Stipulation”) and approved by the Public Service Commission of Utah (“Commission”) on November 23, 2020. Paragraph 13 of the Stipulation states:

As a condition of entering into this Stipulation, the Parties agree to meet with each other and other interested persons in the first quarter of 2021 to identify potential improvements or adjustments to Schedule 34. The Company will, subsequent to those meetings with the other Parties and interested persons, file an application with the Commission seeking approval of any agreed-upon changes or other proposed adjustments to its Schedule 34 tariff.

To comply with this provision of the Stipulation, the Company respectfully requests that the Commission issue at its earliest convenience a public notice that the parties to the Stipulation plan to meet to discuss potential changes to the Company’s Schedule 34 tariff and that any person interested in participating in the discussions should notify the Company by emailing Jana Saba, Regulatory Affairs Manager, at jana.saba@pacificorp.com by February 17, 2021 at 5:00 pm (Mountain Standard Time). After this date, the Company will contact the Division of Public Utilities, the Office of Consumer Services and the other interested parties identified through this process, if any, to schedule the discussions.


