On January 28, 2021, Rocky Mountain Power (RMP) submitted a letter (“Request to Issue Public Notice”) to the Public Service Commission (PSC), explaining that it intends to hold one or more meetings (the “Meetings”) with parties to this docket and other interested persons during the first quarter of 2021 “to identify potential improvements or adjustments to Schedule 34.” RMP and other parties agreed to participate in the Meetings as a condition of the Settlement Stipulation filed in this docket on October 20, 2020.¹

Though the PSC will not host and does not anticipate participating in the Meetings, the PSC issues this public notice that the parties intend to hold the Meetings consistent with RMP’s Request to Issue Public Notice. Any interested person that would like to participate in the Meetings should notify RMP by emailing Jana Saba, Regulatory Affairs Manager, at jana.saba@pacificorp.com by February 17, 2021 at 5:00 p.m. (MST). After that date, RMP will contact those who indicate an interest in participating, along with the Division of Public Utilities and the Office of Consumer Services, to schedule the Meetings.
