Revision of Original Action Request Response (No Additional Action Required)

The Division of Public Utilities (Division) mistakenly referred to Garkane Power Association, Inc.'s Proposed Tariff Revision for Schedule No. EV CHARGING as a voluntary time of use rate. The new proposed tariff is not a voluntary time of use rate. Included below is the Division's corrected Action Request Response removing all references to time of use rate. The Division apologizes for any confusion or inconvenience its error caused.

Recommendation (Approve)

The Division of Public Utilities (Division) recommends the Utah Public Service Commission (Commission) acknowledge Garkane Power Association, Inc.'s (Garkane) proposed Electric Service Tariff Schedule (Tariff). The requested effective date for this filing is April 29, 2021.

Issue

On April 8, 2021, Garkane filed tariff pages to introduce a new rate for commercial EV charging station customers. The Commission issued an Action Request on April 9, 2021 requesting the Division investigate the proposed tariff and report its findings and recommendation to the Commission by April 23, 2021. This memorandum represents the Division's response to the Commission's Action Request.

Background

On April 8, 2021, Garkane filed tariff pages to introduce a new rate for commercial EV Charging station customers. The service is limited to customers whose load requirements do not exceed 2,000 KVA of transformer capacity.

In compliance with Utah Admin. Code 54-7-12(7), weekly notices were published in the February editions of local newspapers throughout Garkane's service territory.

Garkane held a public hearing on March 29, 2021, soliciting member's comments on the proposed addition. No comments were proffered at the hearing. Garkane's board approved the proposed schedule during the public hearing. Garkane filed notification of the new tariff addition with the Commission on April 8, 2021, with a desired effective date of April 29, 2021.

Utah Admin. Code 54-3-3 requires utilities to provide at least 30 days' notice to the Commission prior to the effective date of changes to the utility's "...rate, fare, toll, rental, charge or classification...". As noted above, Garkane filed the tariff with the Commission on April 8, 2021 requesting a tariff effective date of April 29, 2021. Garkane did not provide the requisite 30 days' notice. However, Utah Code 54-3-3 allows the Commission to acknowledge the tariff changes without requiring the 30 days' notice for good cause. The Division sees no significant or

material harm in having not allowed 30-day notice to the Commission, particularly because this is a new rate, not a change to an existing one.

The Division notes Garkane complied with timely notification of its members and held a public hearing. The new rate is designed for commercial customers and appears to leave residential customers relatively the same as before the tariff change.

Utah Admin. Code §746-405-2(D)(6) requires utilities to provide both clean and marked-up versions of tariff sheets identifying the tariff sheet changes. Garkane has indicated this is a new tariff therefore, a marked-up version is not available.

Conclusion

The Division recommends the Commission acknowledge Garkane's EV tariff addition with an effective date of April 29, 2021, without requiring the requisite 30-day Commission notice and make it available for public inspection. The Division recommends the Commission remind Garkane of allowing this 30-day notice in future filings.
