ORDER GRANTING MOTION FOR LEAVE
TO FILE SUPPLEMENTAL TESTIMONY

ISSUED: January 20, 2022

On June 14, 2021, Rocky Mountain Power (RMP) filed a Motion for Leave to File Supplemental Testimony ("Motion"), explaining the written testimony RMP filed in conjunction with its application on March 15, 2021 contained an error and attaching supplemental testimony to correct it. RMP filed the Motion nearly five months prior to the due date for the Division of Public Utilities' audit report and nearly six months prior to the deadline for written direct testimony.¹ No party filed a response or otherwise opposed the Motion.

For clarity in advance of the January 21, 2022 hearing in this docket, the PSC issues this order granting the Motion.
