On February 25, 2022, Rocky Mountain Power (RMP) filed a motion for clarification of the Order Approving Settlement Stipulation ("Order") issued by the Public Service Commission (PSC) on February 23, 2022 in this docket. RMP requests clarification on a single sentence included on page 4 of the Order that reads: "We direct RMP to file an appropriate tariff in compliance with the Settlement and this Order."

The PSC finds that the Order erroneously included the sentence in question, which directs RMP to file a tariff in compliance with the Order even though the Order approved a Settlement Stipulation under which parties agreed to leave RMP's existing tariff in place. The final paragraph on page 4 of the Order should read: "The Settlement is approved as filed."
